806 Crisis Management Plan

Procedures need to be added. Committee requested that the administration complete the procedures and bring the policy back for the December 5 meeting.

903 Visitors to Math and Science Academy Sites and Buildings

Committee Recommends adoption of this policy.

801 Equal Access to School Facilities

Committee Recommends adopting this policy.

907 Rewards

Committee recommends repeal. This is not mandated. The committee does not think MSA would or should offer rewards to solve criminal cases.

807 Health and Safety

This policy is for compliance with the receipt of Health and Safety funding (FIN Code 352). Charter schools have not been eligible for this funding since 2017. The committee recommends repeal of this policy

904 Distribution of Materials on Charter School Property by Nonschool Persons

Committee recommends repeal. The administration is responsible for monitoring visitors and distribution of materials on campus.

902 Use of Charter School Facilities and Equipment

Committee recommends adoption with accompanying administrative procedure.

906 COMMUNITY NOTIFICATION OF PREDATORY OFFENDERS

Committee recommends adoption.

802 Disposition of Obsolete Equipment and Material

There is no charter policy. The ISD policy has references to laws that are not applicable to charter schools. The committee recommends repeal. The committee further recommends that if a charter policy is published the board considers adoption of that policy.

903.1 Respectful Behavior in the Workplace, School and School Sites

This is a MSA created policy that does not get MSBA review or updates. Much of the policy is covered by other policies and our core values. The committee recommends repeal to avoid conflicts arising due to lack of MSBA support.

201.1 Board of Directors Election

This policy is MSA created and cumbersome. The committee recommends more research and consideration of an addition to bylaws stating general provisions about elections and then a board approved election procedure.
